

Saint Peter's College: A Solid Jesuit Education

"Any gift to support an education in the Jesuit tradition is a well-given gift." In reflecting on his educational experience, Lou Cappadona '61 looks back with gratitude to three institutions: Saint Peter's College, Saint Peter's Prep, and St. Mary's University School of Law in San Antonio, Texas.

A Jersey City native who was a member of St. Paul's Parish, Lou attended Saint Peter's Prep. "The Prep molded me when I really needed it," Lou says. "Without it, the rest would not have happened." While in high school, Lou received his introduction to the Jesuits and their traditions of academic excellence and service to others. This led him to choose Saint Peter's College as he pursued higher education.

"Saint Peter's College gave me a solid Jesuit education that helped me earn scholarships to three law schools," Lou says. "The College finished a formation process that began at the Prep." While at Saint Peter's College, Lou was a member of Scabbard and Blade and active in ROTC. ROTC "was a significant part of my education and led to active duty in


the U.S. Army, culminating in the rank of captain in the JAG Corps," he says.

The facilities at Saint Peter's College made a big impression on Lou after his experiences at the Prep. At the time, having a cafeteria with places to sit down was something quite remarkable. "I could not get over that the College had a real cafeteria serving hot and cold food," Lou says. "More importantly, it was the place I met with my fellow students and talked about our classes, our goals at SPC, and our hopes and plans for the future and, for many, the girls we would marry."

Lou has fond memories of the many Jesuits and lay professors who influenced him, including Rev. Jerome Gruszczyk, S.J., who was a "brilliant" biology professor. Maj. Jasper Johnson, a member of the ROTC staff, was truly an officer and a gentleman, Lou says. Angelo Danesino, Ph.D., who embraced the Jesuit tradition of *cura personalis*, took a personal interest in Lou and encouraged him to attend law school. After earning a

offered him a full scholarship. He received his J.D. in 1965.

Lou's law career, which brought him to California, has thrived and focused on traditional labor law and employment law. Additionally, he provides employment law services to several nonprofit agencies, including Para Los Niños, the Grossman Burn Foundation and Mary Health of the Sick nursing home. In his recreational time, he enjoys exercising, both at a local health club and hiking in the Santa Monica Mountains. He is an avid photographer and enjoys the many opportunities for pursuing this interest during visits with his grandchildren.

Lou and his wife, Patsy, have three children and three grandchildren, and reside in Westlake Village, Calif. Despite being more than 3,000 miles from the College, he has helped organize alumni activities in their area over the years. In fact, one of his

favorite memories of Saint Peter's College occurred about 25 years after his graduation at a reunion held at Loyola Marymount University (LMU). The late Rev. James N. Loughran, S.J., attended, as did many of Lou's friends. Lou clearly recalls the Mass in the LMU chapel, where beautiful stained glass windows representing each of the Jesuit colleges and universities in the United States reminded him of the Jesuit connection among all of them. While meeting graduates from all different years, he realized how much the College had done for all of them and how well prepared they were for life after Saint Peter's.

Today Lou continues to practice law, albeit on a reduced schedule. In appreciation for all that he received from the three schools from which he graduated, he has named each of them in his family trust. He has made an unrestricted bequest to the College, noting, "A Jesuit education is even more necessary today than it was when I was going to school. Any gift to support an education in the Jesuit tradition is a well-given gift."

A Great Repeat Opportunity

Help Others With Tax-Free Gifts From Your IRA

If you are looking for the most taxeffective gift to make to Saint Peter's College, Congress extended a law that allows individuals 70½ or older to make tax-free gifts now using funds transferred directly from their IRAs to qualified charitable organizations. You can transfer any amount up to \$100,000 through the end of 2011.

How This Benefits You

 The transfer generates neither taxable income nor a tax deduction, so you do not have to itemize to take advantage of this opportunity.

- The transfer may count against your unsatisfied required minimum distribution from your IRA.
- You can see firsthand the difference your philanthropic dollars make to Saint Peter's College.

Note: The legislation does not permit direct transfers to charitable trusts, donor advised funds, charitable gift annuities or supporting organizations. In addition, this opportunity applies only to IRAs and not other types of retirement plans.


