An Interview With Eugene A. Johnson, Jr. '78

Eugene A. Johnson, Jr. '78 received his B.A. in political science from Saint Peter's and his MBA from the University of Dayton. He retired from Empire State Development Corporation as the director of industry development in 2011. He previously held positions at Public Service Electric & Gas Company, the New York Power Authority and Dayton Power & Light. He and his wife, Lisa, live in Avon-by-the-Sea, New Jersey.

Q. Why did you attend Saint Peter's?

A. Saint Peter's had such a great reputation for its academics and for its strong Jesuit values. I knew that it would be a perfect fit for me and I was right. It also helped that my father, Eugene '43, and uncles were alumni and had great experiences here as well!

Q. Your whole family seems to have a strong connection to Saint Peter's. Were they the strongest influence for your decision to attend?

A. I was so fortunate to have been raised in a large extended family that was full of love. My dad's side was a robust group of Irishmen and my mom was Italian. Typical Jersey City at that time!

My parents' values were simple: love of God and family, work hard, learn and give back. My dad used to say, "Education is an opportunity, only if you take advantage of it!" They both made many sacrifices for my brother (Chris), sister (Madonna) and me. They were happiest being around family and friends.

My dad was especially appreciative of the Jesuit community, attending the Prep and the College. Attending Saint Peter's during the war times was turbulent for young men and women, especially those participating in ROTC. My dad's experiences during the war as second lieutenant further shaped his love of nation and family. His unit helped liberate the Buchenwald Concentration Camp in 1945; this became an emotional-scarring "secret" to him for most of his life. He only spoke of it during his final days. When he returned from the war, it was the Jesuits that assisted him with finding acceptance into Georgetown Law. He then clerked in Hoboken, followed by a successful, life-long law practice.

Q. Did Saint Peter's prepare you well for your career and life after college?

A. Absolutely. Saint Peter's taught me how to be successful in life, not only professionally, but as a caring individual through the Jesuit values that were instilled in me.

Lisa Thottumari '17 is a biology major with a minor in chemistry at Saint Peter's University. She is a graduate of Livingston High School and currently resides in Livingston, New Jersey.

Q. Reflecting back on your time at Saint Peter's, what are some of your favorite memories?

A. One of my favorite memories at Saint Peter's so far was when I traveled to New York City for my *Space*, *Place*, *and the City* class, a theology elective for students in the Honors Program.

The course was centered on analyzing sacred spaces in the city. Our travels took us to churches, Hindu temples, synagogues and a Buddhist shrine. I was able to learn about different religions and traditions while traveling through New York City.

It was amazing to be able to experience these spaces first-hand while others may only read about them or hear about these places in the classroom. That is what's so great about being so close to New York! It affords us so many opportunities as an undergrad.

Q. How would you describe a Saint Peter's education to our alumni?

A. A Saint Peter's education is very hands-on. Faculty have a vested interest in each of us and look to provide us with a real life experience.

This semester I am taking a *Perspectives of Politics* class. It is an introductory political science class and it is one of the classes that are required in order to graduate. Although I was not interested in the subject, my teacher, Professor Philip Plotch, makes the class very interesting by using real-life examples to show why politics is an important topic and why it is relevant to everyone. His lectures consist of discussions that are often very thought provoking. I enjoy the class and how it has challenged my views on politics.

Q. What would you tell a prospective student about why they should come to Saint Peter's?

A. The professors who work at Saint Peter's really care about their students. They are always available to help students who are having trouble and oftentimes they become friends.



Q. What do you want your legacy to (Saint Peter's to) be?


A. Simply knowing that I gave back to an institution that gave to me so much is exactly what I wish my legacy to be.
